Racial Equity Spotlight

On June 17, 2021, President Biden signed legislation establishing June 19th - "**Juneteenth**" - as a federal holiday. The date has been celebrated in cities across the country since its inception but many Americans are just beginning to understand what it signifies. While the Emancipation Proclamation formally ended slavery in the confederate states in 1863, there were few Union soldiers in Texas to enforce the abolishment. Slaves were kept in Texas for another two and a half years until June 19, 1865, when a Union general emancipated the remaining slaves. Since then, the date has been celebrated annually and is considered the longest-running African-American holiday. Traditional celebrations often include recitations of the Emancipation Proclamation, street fairs, readings of work by Black authors, and voter registration efforts.
